



## LICENSE AGREEMENT

### Ultimate X Sounds – End User License Agreement (EULA)

By purchasing and downloading products from Ultimate X Sounds, you accept and agree to be bound by the terms of this License Agreement.

#### 1. Grant of License

The license for this product is granted only to a single user ("Licensee"). All sounds, scripts, presets, and samples in this product are licensed, not sold, to you by Ultimate X Sounds.

- **Scope:** This license allows for commercial and non-commercial use in music production, sound-effect creation, audio/video post-production, broadcast, live performance, or similar finished content creation.
- **Royalty-Free:** Ultimate X Sounds grants you the right to use the purchased content in commercial recordings without paying any additional license fees.
  - **Attribution:** You are not required to provide source attribution to Ultimate X Sounds in your finished works.
  - **Duration:** The license to use the files is indefinite, provided that you comply with all terms of this agreement.

#### 2. Restrictions on Use

This license expressly forbids the following:

- **No Third-Party Marketplaces:** You are strictly prohibited from uploading, hosting, offering, or selling this product on any third-party marketplaces (including but not limited to eBay, Amazon, Reverb), auction sites, or file-sharing platforms without the express written consent of Ultimate X Sounds.
- **No AI Training:** You are expressly prohibited from using any content contained in this product for the purpose of training, testing, or refining any Artificial Intelligence, Machine Learning, or Deep Learning algorithms or systems.

- **Non-Transferable:** This license is non-transferable. You may not resell or transfer your license to another entity or individual without the express written consent of Ultimate X Sounds.

#### 3. Intellectual Property Rights

Ultimate X Sounds retains full copyright privileges, intellectual property rights, and complete ownership of all recorded sounds, instrument programming, documentation, and musical performances included in this product.

- **Demo Tracks:** The demo tracks and musical compositions included in the marketing of this product are for demonstration purposes only. This license grants rights to the individual sounds/presets used, but does not grant any rights to the musical compositions or melodies showcased in the demo tracks.

#### 4. Refund Policy
